



WCO HS Codes and SCSR Product List




The following is a guideline on matching of the World Customs Organizations' Harmonized System (HS Codes) against the product categories defined in Schedule I of the Standards (Compulsory Standards) Regulations, 2023 (SCSR). These notes do not negate any of the scope as defined in the explanatory notes of the HS Codes or the standards as defined in the SCSR.





The tables are to be used by customs officers, clearing agents and traders when evaluating consignments of goods entering Botswana. If the Customs system flags an HS code for potential need of a Certificate of Compliance and the Customs officer is not sure if the specific cargo is required to have a certificate for the SCSR, then the Customs officer can look up the HS code in the first column. The table will give a brief note on the scope of the HS code. Then the next columns will specify examples of what is covered and what is not covered as per the SCSR.





Where the WCO HS code is limited to four or six digits, then all subsections falling within those digits are considered to be included. The table is sorted in the ascending order by the WCO HS codes for ease of searching.



